# GAR Awards 2020 – the Pledge award

The GAR Awards 2020 nominations process continues tonight, as for the first time we publish a public shortlist for the Equal Representation in Arbitration Pledge Award.

Together, GAR and the steering committee of the Pledge – a initiative to promote the appointment of women as arbitrators on an equal opportunity basis – wanted to recognise a person or organisation for outstanding commitment to gender diversity in the field of international arbitration.

At last year's GAR Awards, the inaugural Equal Representation in Arbitration Pledge Award was won by the Equity Project, an initiative led by Burford Capital to promote women in the law, after it was selected by the Pledge steering committee.

However, this year the award will be subject to a public vote. The nominations are below, with links to the relevant GAR article where available. A voting form will be published online next week to allow you to cast your votes.

The 2020 GAR Awards will be held on 2 April at the InterContinental Paris le Grand, forming part of Paris Arbitration Week. It will begin with the unveiling of the GAR 30, the annual ranking of the world's most active arbitration practices, followed by the presentation of our annual awards.
